PCI Compliant Log Management

MegaPath's Managed Logging service is a cloud-based offering that securely collects, analyzes, reports, and stores log data from MegaPath-provided or customer-owned security devices, network infrastructure, and host systems. The service uses an agentless approach to log collection that is rapidly deployable and scalable in all customer environments. For Windows *-based POS systems, the service also offers an optional File Integrity Monitoring (FIM) function for additional PCI compliance.

Vulnerability Management

MegaPath's Vulnerability Scanning service (VSS) provides Web-based scanning tools for unlimited internal and external scanning by the customer. The service provides detailed scan reports and priorities on identified vulnerabilities that can be remediated by the customer or MegaPath. In partnership with multiple approved scanning vendors (ASVs), we also provide quarterly scan certification reports required to meet the PCI-compliance requirements.

Security Information Management

Our security portal is included at no additional cost with the purchase of either Managed Logging or VSS. It provides case management, workflow, and log or vulnerability issues reporting that can be used to track remediation activities, as well as create reports for audits and assessments. Its Security Information Management (SIM) functionality is a key element to maintaining effective security controls and demonstrating compliance.
